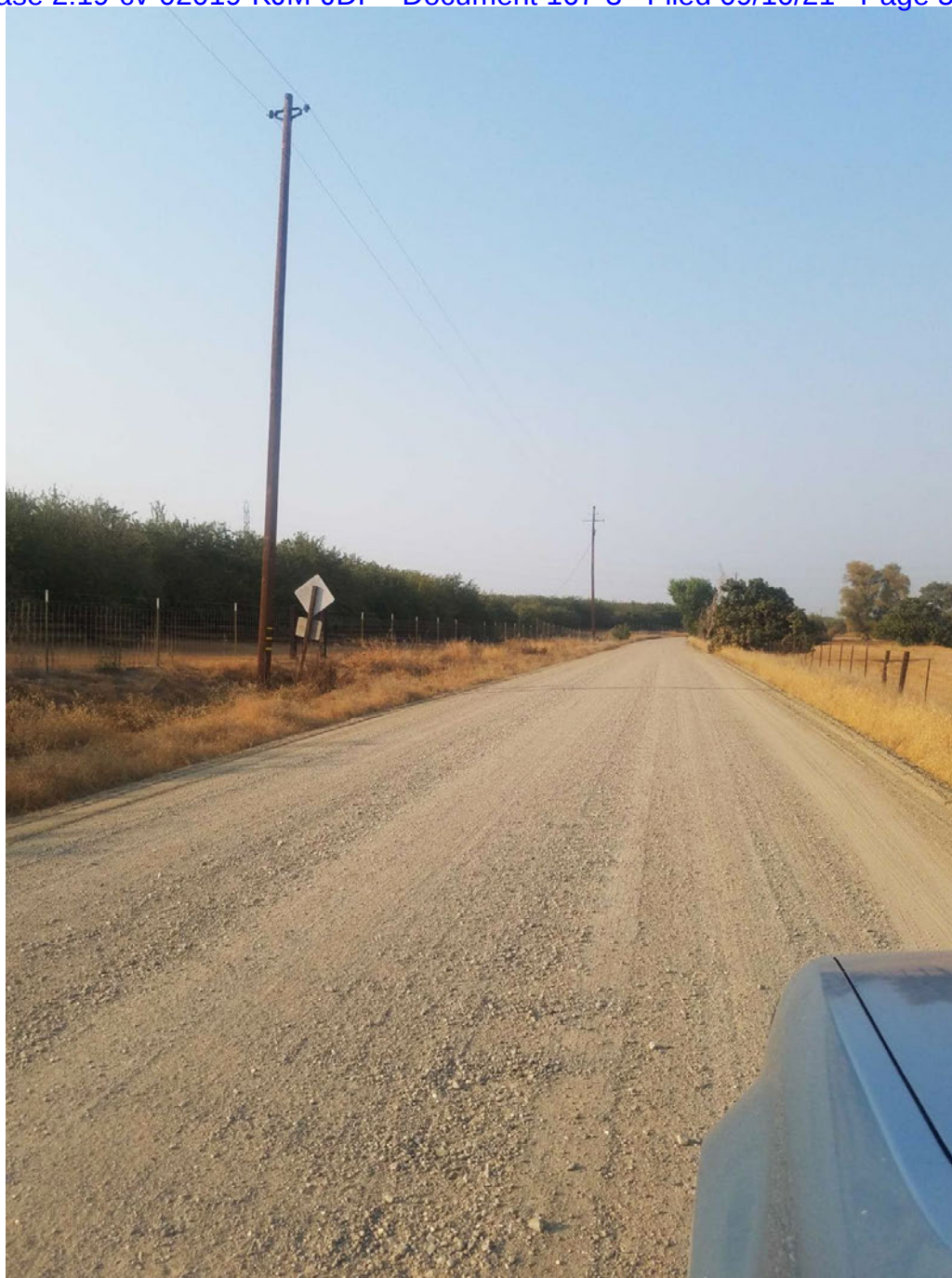

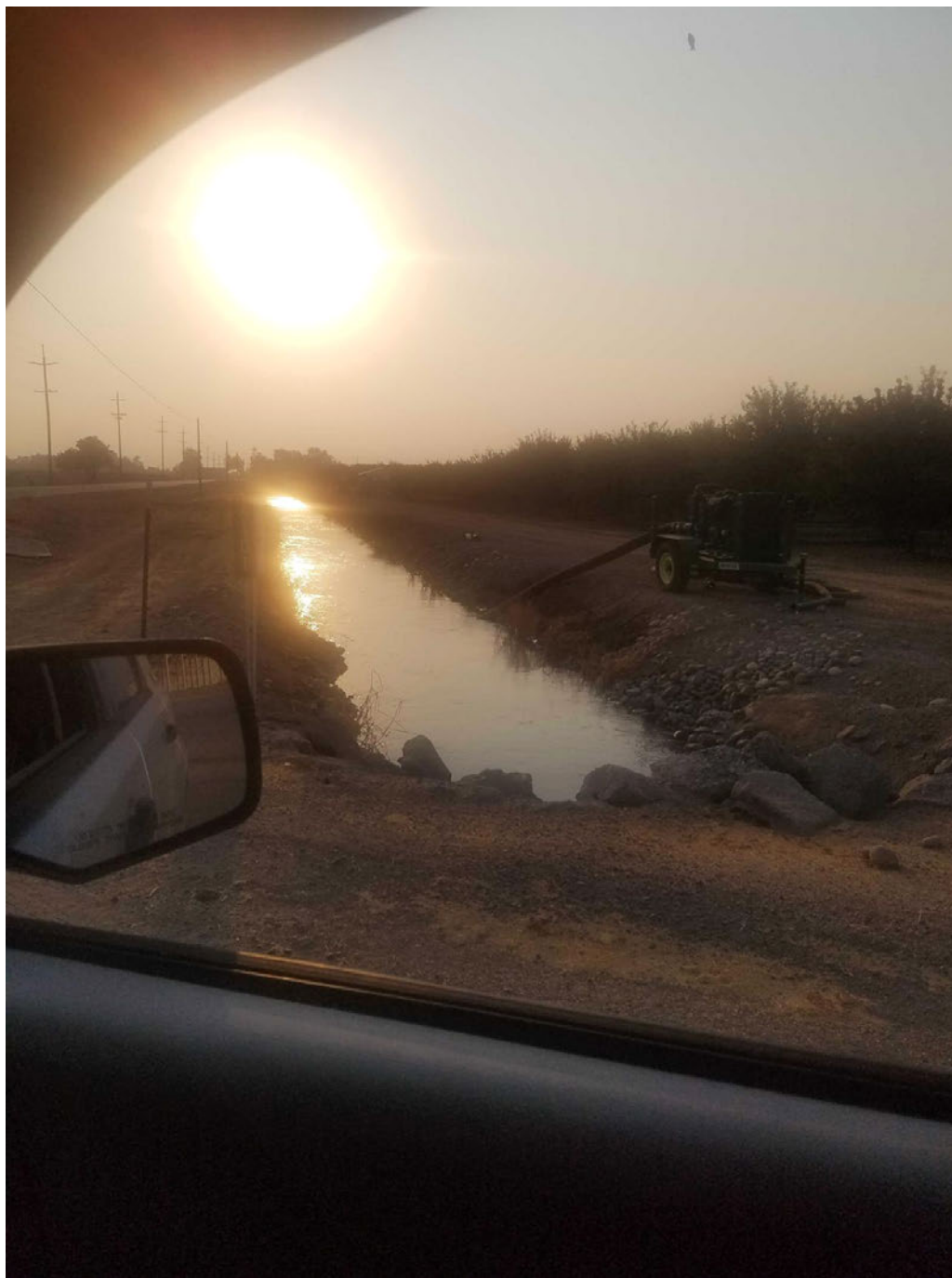

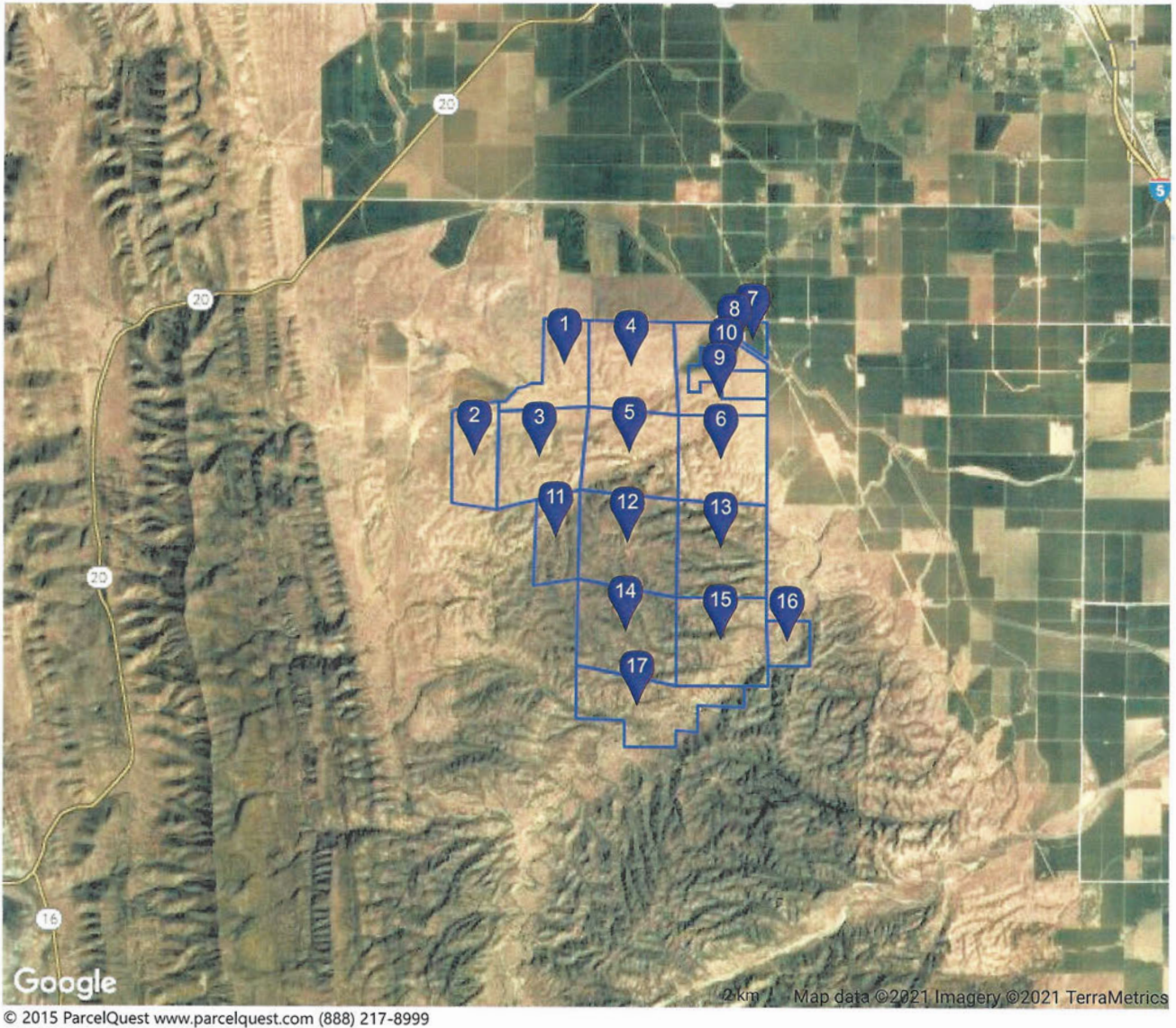

MEMORANDUM OF AGRICULTURAL LEASE

(SPRING VALLEY RANCH PARTNERSHIP
and VANN-PETERSON FARMS PARTNERSHIP)

This Memorandum of Agricultural Lease is made this 20th day of May, 2009, between SPRING VALLEY RANCH PARTNERSHIP, a California general partnership (herein called "Landlord"), and VANN-PETERSON FARMS PARTNERSHIP, a California general partnership (herein called "Tenant"), who agree as follows:

1. Lease. Lessor hereby leases to Lessee and Lessee hereby leases from Lessor, pursuant to the terms and conditions of that certain Agricultural Lease of even date herewith by and between Landlord and Tenant ("Lease") that certain real property referred to in the Lease as the "Premises," which is more particularly described in **Exhibit A** attached hereto and incorporated herein by this reference.

2. Leasehold Financing. Subject to the provisions of the Lease, Tenant may encumber its leasehold interest in the Premises. The Lease contains provisions for the protection of a leasehold lender, including without limitation, that Landlord shall provide to such lender certain notices, cure rights and rights to obtain a new lease, and that Landlord shall not agree to any mutual termination nor accept any surrender of the Lease or the Premises (except on the expiration of the term of the Lease as provided for in the Lease, or except as ordered by a judge or arbitrator due to the Tenant's default under the Leases) nor shall Landlord consent to any material amendment or modification of the Lease, without the prior written consent of Lender, all as more specifically set forth in the Lease.

3. Purpose of Memorandum of Agricultural Lease. This Memorandum of Agricultural Lease is executed, prepared and recorded for the purpose of giving notice to all parties of the provisions of the Lease which affect the Premises. This Memorandum of Agricultural Lease is prepared for the purpose of recordation and notice, and it in no way modifies the provisions of the Lease, or any amendments thereto, the terms of which are incorporated herein by reference. In the event of any inconsistency between the terms and conditions of the Lease and the terms and conditions of this Memorandum of Agricultural Lease, the terms and conditions of the Lease shall control.
